

Guiselle Mejía Chavarría Director Emergency System 9-1-1 Costa Rica

Ms. Mejía Chavarría was appointed Director of the Emergency System 9-1-1 in February 2016. Since then, she was involved in the process and approval of the Law No. 9547, as an amendment to Law No. 7566, which stipulated the Creation of the Emergency System 9-1-1. Ms. Mejía

Chavarría has also played a crucial role in strengthening the financial situation of Costa Rica's 9-1-1 System. She has also been working to consolidate the System's national and international presence.

Ms. Mejía Chavarría has 30 years of professional experience in the public sector, of which 22 took place at the Costa Rican Electricity Institute (ICE, for its Spanish acronym). Between 2011 and 2015 she excelled as ICE's Director of Wholesale Management. In that position, she was responsible for the negotiations and contracts of access and interconnection of fixed and mobile networks, virtual mobile operations, and scarce infrastructure.

Ms. Mejía Chavarría holds a Bachelor's degree in Economics and a Master's degree in Business Economics, both from the University of Costa Rica (2001). She then obtained two postgraduate degrees, one from ADEN Business School's Senior Management Program (2009), and the other in Management of Strategic Telecommunications from the International Telecommunication Union (ITU) (2014). Also from ADEN Business School, she also obtained a Specialization in Management Skills (2016).
